Happy Homes Adoption Program: housed, provided veterinary care including spay/neuter, and found suitable homes for 97 dogs and 130 cats; in many cases, transported adopted pets to their new homes within the Pacific Northwest.

**4b** (Code: 900099 ) (Expenses \$ 3650 including grants of \$ 0 ) (Revenue \$ 0 )

Stop The Cycle Spay/Neuter Program: Provided spay and neuter vouchers to low income pet owners, who had their choice of participating veterinarians spay and/or neuter their pets. A total of 29 dogs and 57 cats were spayed or neutered.

**4c** (Code: 900099 ) (Expenses \$ 2848 including grants of \$ 0 ) (Revenue \$ 0 )

Fear No Feral Program: Assisted property owners with humane trapping of 66 feral cats, which were provided veterinary care including spay/neuter, ear-tipping, and rabies vaccination. Of the cats served, 44 were released at the same Location from which the were trapped (Trap-Neuter-Release); 0 were adopted as barn cats; 10 were transferred to the Happy Homes Adoption Program; and 12 either died from pre-existing illnesses or defects, or were euthanized due to extreme aggression or illness.
