Happy Homes Adoption Program: housed, provided veterinary care (including spay/neuter), and found suitable homes for 126 dogs and 228 cats, and in many cases transported adopted pets to their new homes within the Pacific Northwest

**4b** (Code: ) (Expenses \$ 10,441 including grants of \$ 0) (Revenue \$ 0)

Stop the Cycle Spay/Neuter Program: provided spay/neuter vouchers to low-income pet owners who had their choice of participating veterinarians spay and/or neuter their pets. A total of 54 dogs (28 spays, 26 neuters) and 128 cats (74 spays, 54 neuters) were spayed or neutered.

**4c** (Code: ) (Expenses \$ 12,296 including grants of \$ 0) (Revenue \$ 0)

Fear No Feral Program: Assisted property owners with humane trapping of 137 cats, which were provided veterinary care, including spay/neuter, ear tipping, and rabies vaccination. Of the cats served, 38 were released at the same location where they were trapped (trap-neuter-release, or TNR); 34 were adopted as barn cats; 65 were transferred to the Happy Homes Adoption Program; 0 are still waiting for homes; 0 was euthanized for health reasons.
